Chairman Michael Harper called meeting to order.

APPROVAL OF PREVIOUS MEETING MINUTES

Minutes are not available at this time for approval and acceptance.

PAYMENT OF CLAIMS FOR JULY 2022

There were no questions or concerns from Commissioners. Motion to approve payment of claims made by Commissioner Pardasani; 2nd by Commissioner Mondadori.

REMARKS OF CITIZENS – nothing at this time

COMMITTEE REPORTS

FINANCE COMMITTEE – Bank balances through June 30, 2022 in each Commissioner's packet. Note inside states \$175,000 taken out from TD Bank account on 7/25; opened up an 18-month Certificate of Deposit at Bogota Savings Bank – 2.25% interest rate/APY 2.28%. Bogota Savings Bank also increased interest rate on 2 accounts from .40 to .850. FED raised rate again today, SHA will see after August 1 if any bank has an attractive rate that some SHA money can be moved there for 6, 12 or 18 months.

Commissioner Pardasani, Chairman Harper, Commissioner Fairman met at 2:30 PM along with Bill Katchen and Anthony Polcari. Polcari & Company finished audit today for SHA. Commissioner Pardasani said everything was good. Commissioner Fairman stated meeting was good, no surprises, liked consistency of Policari work, happy they are SHA external auditor. ED Marra thanked all SHA staff who helped with this endeavor – checking files for compliance, Terry Weinbrecht and Tanya Oquendo; Angie Oliveros, Linda Fanning, Fran Pein – all contribute to have these audits come off well; Bill Katchen and his staff. SHA gets a copy of audit and Policari will be auditors for Leased Housing Corporation for Town of Secaucus; having completed 2 audits: 1 ending 3/31/21 and 3/31/22. Going forward they will always be auditor, unless Leased Housing decides to change; 2 done at same time works for efficiency.

PROFESSIONAL SERVICES - N/A

PERSONNEL COMMITTEE – Effective July 31st, Greg Kohl, Maintenance Technician, retiring; worked for SHA a little over 10 years, starting off as Custodian; promoted to Maintenance based on the fact he could change hot water heaters, saving SHA a tremendous amount of money even with raise he got; doing a good job. When Harry left, Greg became main Maintenance man at The Elms. Adam Quinones has taken over that role; SHA has posted through Town of Secaucus and our web site, the job. In addition we sent out over 250 letters to allies of SHA. Most of them are families that are receiving Section 8 or local contractors to see if they had any references for us, who might be interested.

Other item on agenda to be discussed in Closed Session is now that we've concluded contract for personnel, we need to discuss Executive Director's contract.

POLICY COMMITTEE FOR SMOKING

Information received back from HUD, giving reports which in the future over next few weeks, will be shared with Commissioners intermittently and am waiting for information back from JIF and other housing authorities contacted about how they enforce their policy.

Commissioner Fairman stated that smoking matter needs to have a strong priority toward the September meeting. ED Marra agreed.

BUILDINGS & GROUNDS

Completed last month was Main Access Control with a few problems along the way, mostly at The Elms, but seemed to have been ironed out.

People in this audience, beginning week of August 9th Geocon will commence beginning of replacement of 84 apartment doors at 600 County Avenue, starting on 10th floor working their way down. According to contractor yesterday, he believes 3 apartments can be completed each day., but don't know how many men they're sending, meaning technically they should be finished with 2 floors each week – 15 apartments/week; hope they can maintain that pace.

In early September, we expect modernization of elevators at 600 County to commence.

We still have removal and replacement of windows and EFIs at The Elms. We have a grant application in with County of Hudson. Those awards get announced in October. Once they're announced, SHA will put job out to bid.

HOUSING CHOICE VOUCHER (HCV) PROGRAM

Commissioners have report about HCVP. Now SHA is funding up to 228 families for about \$241,000, including breakdown of how that works.

We received our SEMAP score, which was not required to be submitted for 2 full years due to COVID – SHA not submitting in 2020-2021. Have submitted for year ending 3/31/22 – half of Linda and half of Jake, scoring a 96 or "high performer" which we were when Jake was doing it. Linda happy to receive that as well as Angie Oliveros.

NEW BUSINESS

SHA is working with contractor who does most of the work for Town of Secaucus – outdoor furniture. Outdoor furniture at Kroll Heights, tables/benches on patio and 4 benches located in front of Towers, are going to be replaced with similar looking furniture – iron type/maroon colored/diamond shaped cutouts. Order put in on Tuesday - \$13,000 through State Contract, don't know when it will get here – early Fall. \$13,000 includes actual furniture but some of it is installed – bolted into the ground. New furniture not needed at The Elms at this time.

REMARKS OF CITIZENS

DOREEN MORGAN - #708 – There are some concerns about overflow of recyclables on weekends. ED MARRA: 6-8 months ago, SHA began to have a maintenance man come in to change compactor bag in the bottom. On a Sunday about 8 months ago, SHA changed it to compactor changed on Sunday, maintenance man would go into each building: Kroll & The Elms, to empty recycling compactor closet. At your building, no one actually changes it because Joe actually changes it on his own – doesn't get paid for doing that, except when he's man on call, and has been emptying them on his own. I will bring this to his attention tomorrow. Doreen said it's on her floor – 3rd floor.

CAROL STEWART - #216 – What does SHA do with money collected from washers/dryers? ED MARRA: It is collected as revenue for SHA. When we need to buy new washers/dryers or get repairs, we use that money; mostly it becomes part of the budget. Revenue-wise, it's probably like \$35,000 a year.

Carol suggested 2 years ago that garbage/recyclables be put on table, bring Spanish speaking residents down and explain: paper here – garbage here – plastics here because people still mix it up. ED MARRA: Usually on Sunday, it's empty. Carol said yes. ED MARRA: Men leave after 3 PM on Friday. Office staff leaves at 12:00 on Friday as they work extra time Monday-Thursday. We will have one meeting in each building; difficult to get everyone in a building to attend – yes, Spanish and English.


